Objectives and Investment Policy

The Investment Objective of the Sub-Fund is to achieve mid-term capital appreciation. The Sub-Fund seeks to accomplish this objective through investing primarily in US related financial instruments. These investments are made directly through fixed income and equity securities but also indirectly through UCIs/UCITS including ETFs.

The Sub-Fund is managed following a sectorial diversification, based on a dynamic investing methodology combined with the objective of preserving capital. The Sub-Fund is mainly invested in US related equities and bonds (including but not limited to convertible bonds, high yield bonds [with a maximum exposure of 10% of the Sub-Fund total net assets], fixed-rate or floating securities, zero-coupon bonds and treasury bonds), UCIs/UCITS including ETFs, money market instruments and deposits. In any case, the total allocation to other UCIs should not exceed 30% of the Sub-Fund total net assets.

For hedging and on ancillary basis for investment purposes, the Sub-Fund may use financial derivative instruments products traded on a regulated market and/or over the counter (OTC), provided they are contracted with first class financial institutions specialized in this type of transactions. In particular, the Sub-Fund may take exposure through financial derivative instruments

and forwards on any eligible underlying, such as currencies, interest rates, transferable securities or financial indices, at all times in compliance with the Grand Ducal Regulation.

If the Investment Manager considers this to be in the best interest of the Unitholders, and notably for defensive purposes, the Sub-Fund may also, hold, up to 100% of its net assets, liquidities such as (but not limited to) cash deposits and money market funds.

The Sub-Fund will capitalise its entire earnings following an income accumulation policy.

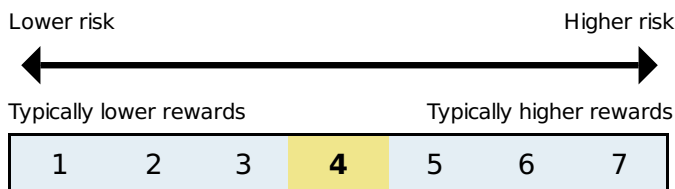
The Share Class' currency is EUR. The Sub-Fund's reference currency is EUR.

Risk and Reward Profile

The following risks may materially impact the Sub-Fund but are not captured by the indicator:

Credit risk: The default of the issuer of a debt instrument held by the Sub-Fund.

Liquidity risk: Securities in the Sub-Fund may be sold below their valuation due to insufficient liquidity in the market.

Counterparty risk: A counterpart may fail paying the proceeds related to the sale of securities by the Sub-Fund or may fail delivering the securities purchased by the Sub-Fund. A counterpart of the Sub-Fund in an OTC derivative may fail satisfying its obligations towards the Sub-Fund at any event of the OTC derivative agreement.

Operational risk: Failures or delays in operational processes may negatively affect the Sub-Fund.

Derivatives risk: Derivatives may be used to increase, lower or maintain the risk level of the Sub-Fund. The derivative strategy may fail resulting in significant losses for the Sub-Fund.

Currency risk: Exchange rate fluctuations may negatively affect the value of the Sub-Fund's investments.

Event Risk: The overall value of all types of investments may be affected by devaluations, political and governmental interventions in relevant markets or irregular and sudden market fluctuations.

The above mentioned list of risk factors is not exhaustive. Other factors may influence the pricing of the underlying securities and therefore the value of the Sub-Fund's investments.
